1. Government of Assam has received a loan from Asian Development Bank (ADB) towards the cost of the Assam Urban Infrastructure Investment Program (AUIIP) Project-1. Part of the proceeds of this loan will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.
2. The Guwahati Development Department, Government of Assam (The Employer) represented by Project Director, AUIIP invites bids from experienced and eligible bidders for "Construction of Compost Plant Sheds at SWM Plant in Dibrugarh".
3. Particular details of works are construction of civil work and sheds as per the detailed specifications mentioned in Section 6, in Dibrugarh, Assam, India.
4. The estimated contract period for the entire work shall be 12 Calendar months.
5. National Competitive Bidding (NCB) will be conducted in accordance with ADB's Single stage-Two envelope bidding procedure and has to be submitted below mentioned address which is open to all eligible bidders from eligible source countries.
6. The bidder should pay **INR 20,000.00** (Rupees Twenty Thousand Only) for Tender Fee in favour of Project Director, AUIIP Guwahati, payable at Guwahati by Demand Draft of any Nationalized /Schedule Banks.

7. Interested eligible Bidders may purchase the Bidding Document from the office of Project Director, Project Management Unit (PMU), AUIIP, Guwahati from 05/02/2020, 4.00 pm to 05/03/2020, 1:00 pm of given below address on working days only.
8. All corrigendum, addendums, information related to the bid shall be available in the website www.auiip.nic.in. and news paper.

The bidders shall furnish a **Bid Security/EMD of INR 1.75 Million** in favour of Project Director, AUIIP Guwahati, payable at Guwahati through unconditional Bank Guarantee / Fixed Term Deposit of any Nationalized/Schedule Banks along with bid. The Bid Security/EMD shall be valid beyond 28 days from bid validity.
10. The Employer shall not be responsible for any costs or expenses incurred by Bidders in connection with the preparation or delivery of Bids.
11. Bid sent by E-mail shall not be accepted.
12. Pre-bid meeting with the bidders shall be held at the PMU, AUIIP office on 20/02/2020 at 3:00 PM, conducted by the Project Director, AUIIP. Bidders interested in participating in bid process are advised to attend pre-bid meeting and visit site before submission of bid.
