Contract Title: Construction of Compound wall, River Protection Wall, Access Roads, Security Guard Room and Allied Works of Landfill site at Dibrugarh.

1. Government of Assam has received a loan from the Asian Development Bank (ADB) towards the cost of the Assam Urban Infrastructure Investment Program (AUIP)-Project 1. Part of this loan will be used for payments under the contract named above. Bidding is open to bidders from eligible source countries of the ADB.

2. The Urban Development Department, Government of Assam (the Employer) represented by Project Director, Project Management Unit, AUIP invites sealed bids from eligible bidders for the Construction of Compound wall, River Protection Wall, Access Roads, Security Guard Room and Allied Works of Landfill site at Dibrugarh.

The main works comprise of Construction of Compound wall with Barbed Wire fencing, River Protection wall, Internal Roads at Landfill site, Erection and fixing of Gate (2 Nos.) and Security Guard Room etc.

3. Particular details of works are:

- Construction of compound wall of 1400 meters in length and 1.5 m in height has been proposed all along the landfill plot for protection of the plot from trespassing and infringement, the length excludes the length of the retaining wall to be provided as a flood protection measure. Barbed wire fencing will also be provided over the compound wall as shown in the drawings enclosed in the bid document.
- It has been proposed to construct a retaining wall of 950 meters length and 3.5 meters height, along the landfill site as a flood protection measure from the near by flowing Sessa River.
- In order to connect the infrastructural facilities such as Compost plant, Leachate treatment unit, Landfill site, office building, operator's rest room with water and sanitation arrangements etc. located inside the SWM treatment site, internal roads for a length of 2300 m and width of 6m are proposed inside the compound of SWM treatment site.
- Two numbers of iron gates of approved design will be provided at the entrance of the compound walls proposed for SWM site and compost plant site.
- Security Guard room will be provided at the entrance of the SWM site to safeguard the materials, machineries and equipment inside SWM site.

4. The estimated construction period for the entire works is 730days.

5. National Competitive Bidding will be conducted in accordance with ADB's Single-Stage: Two -Envelope bidding procedure and is open to all bidders from eligible source countries.

To purchase the bidding documents in English, eligible bidders should write to the address above requesting the bidding documents for AUIIP/PR-1/DIB/SWM/01A, Construction of Compound wall, River Protection Wall, Access Roads, Security Guard Room and Allied Works of Landfill site at Dibrugarh by paying a non-refundable fee of INR 20,000/- (INR Twenty Thousand only) for receiving it at the AUIIP office for the package, starting from 31st Dec, 2016 to 28th Jan, 2017, and INR 5,000/- (INR Five Thousand only) for delivery within India; or INR 10,000/- (INR Ten Thousand only) for delivery outside India. The method of payment will be through demand draft in favor of the Project Director, Assam Urban Infrastructure Investment Program (AUIIP) payable at Guwahati between 10:00 to 17:00h at the office mentioned under item 6.

9. The Employer will not accept any liability for loss or late delivery. The bidding documents will be issued in hard copy only.

10. Bids should be delivered:

- To the address above and on or before the deadline: 30th Jan, 2017 at 14:00h together with a Bid Security as mentioned in clause ITB 19.1 of section 2 Bid Data Sheet.

11. Bids will be opened immediately after the deadline in the presence of bidders representatives who choose to attend.

12. ADB's Domestic Preference Scheme will not be applied.
