MINUTES OF EOI EVALUATION COMMITTEE MEETING

Minutes of the EOI Evaluation committee meeting which is Evaluation of Expression of Interest for shortlisting of Consulting firms "PREPAREATION OF DETAIED PROJECT REPORT FOR TWO WATER SUPPLY PROJECTS FOR GOALPARA AND GOLAGHAT town in the state of ASSAM" held on 29/11/2023

- 1. The chairman of the Evaluation committee cum Project Director, Assam Urban Infrastructure Investment Program (AUIIP) welcomed the members of Evaluation committee and apprised the members that the meeting is going to be convened for finalization of shortlisting consulting firms and to invite in submission of combined Technical & Financial proposal to undertake the assignment.
- 2. List of attendance attached Annexure-C
- 3. The member secretary explained that prior to shortlisting; the eligibility of all the participated firms were scrutinized as per stipulated eligibility criteria in both hard copies as well as in soft copies of submitted EOI. In this connection, after verifying the proposals, a comprehensive report along with EOI evaluation sheet is prepared for review and comments observed if any by the committee.
- 4. As far as DRA consultant is concerned the committee was in a view that for eligibility criteria related to environmental and social safeguard for MDB projects, the consultant has done one project for 21 towns and one project as a consortium member where similar activity was part of the overall assignment. Hence, the committee recommended DRA consultant for shortlisting.
- 5. In case of Samarth Infratech, the committee found that the consultant has placed both similar experience in urban areas in India and environmental and social safeguard experience in form 4(B). however, as they are mitting the minimum eligibility criteria the committee considered Samarth for shortlisting.
- 6. In case of Vitya Consultants Pvt Ltd, the PF & ESI is not applicable (Employees Provident Funds and Miscellaneous Provisions Act 1952, Act No. 19 of 1952) as the total number of employees are not more than 20, hence they are also considered for shortlisting in the EOI stage.
- The short-listed firms are to be invited to submit a combined Technical & Financial proposal to undertake the assignment of developing "PREPARATION OF DETAILED PROJECT REPORT FOR TWO WATER SUPPLY PROJECTS FOR DHUBRI AND BONGAIGAON TOWN IN THE STATE OF ASSAM".
